## Notification No. 077-BOPEE of 2025 Dated 21-07-2025

Consequent upon the declaration of the Result/Provisional Merit List of the Common Entrance Test for admission to **B.Sc. Nursing/B.Sc. Paramedical/B.Sc. Technology Courses-2025** vide *Notification No. 051-BOPEE of 2025 dated 29-05-2025*, it is hereby notified for information of all the concerned candidates that the Board shall conduct the First Round of Online Counselling of only those candidates who have secured the Rank up to **26451** in the Provisional Merit List issued vide *Notification No. 051-BOPEE of 2025 Dated 29.05.2025*.

It is for the information of all the candidates that the seats shall be allotted based on the credentials of the candidates mentioned in *Annexure-A to the Notification No. 051-BOPEE of 2025*, Dated 29.05.2025. The Board shall in no case be held responsible if a seat is allotted to any candidate based on the incorrect category mentioned in the online application form.

## Note:

- 1. No representation shall be accepted /entertained by the Board through any E-mail or WhatsApp mode.
- 2. The online filling up of choices/preferences shall be available w.e.f. 22.07.2025 to 26.07.2025 (Midnight) and the instructions related to filling up of online Choices/Preferences have already been mentioned in the Counselling Procedure, which is available on the official website of the Board (www.jkbopee.gov.in) only.
- 3. Further, the candidates must pay an online counseling fee of **Rs. 1000/-** as mentioned in e-Information Brochure/counselling procedure, and after submitting the online Preferences, the candidates must take out the printout of it and ensure that the payment of Rs. 1000/- must be reflected in the payment column.
- 4. The Board shall provisionally allow all such candidates to participate in the online counseling process who have failed to upload any of the documents, viz. Domicile Certificate, 10<sup>th</sup> Class Marks Card, 12th Class Marks Card/Diploma to ascertain the D.O.B etc. with the condition that they must fulfill all the

- eligibility conditions as mentioned in the Notification No. 031-BOPEE of 2025 dated 17.03.2025 and have to submit all such documents at the time of their admission in the respective college, if selected.
- 5. It is further enjoined upon all the concerned candidates to ensure the validity of the Category Certificate, which in any case should not have been issued after **26.07.2025**, i.e., the last date fixed by the Board for filling up of online preferences for the B.Sc. Nursing/B.Sc. Paramedical/B.Sc. Technology Courses, 2025.
- 6. The seats shall be allotted to the candidates as per **S.O. 176 dated 15-03-2024 read with S.O. 305 dated 31-05-2024** issued by Social Welfare Department, UT of J&K.
- 7. Seat Matrix shall be uploaded on the website of the Board a day before the start of choice filling.
- 8. Regarding **the fee structure** of the courses, participating candidates are advised to confirm it from the respective College/Institute where they intend to seek admission before applying for the online process.
- 9. Mere filling up of the online Preferences/ Choices shall not confer any preferential right/claim upon the candidate concerned for admission to any course/college, which shall further be subjected to eligibility to be verified at the time of admission, if selected, by the respective College/Institution.
- 10. The admission of the candidates is purely provisional. It shall be liable to be cancelled in case any information provided by any candidate is proved to be false/fabricated/untrue at any stage. The Board reserves the right to cancel the same and take penal action as per relevant rules against the candidate(s) concerned.
- 11. The candidature of any such candidate who is found ineligible at any stage of admission shall be cancelled without any further notice.
- 12. The other Terms and Conditions shall remain the same as notified by the Board through the e-Information Brochure, Notifications & Notices issued from time to time in this regard.
