Consequent upon the declaration of the Result/Provisional Merit List of the Common Entrance Test for admission to GNM/ANM Courses-2025 vide Notification No. 057-BOPEE of 2025 dated 10-06-2025, it is hereby notified for the information of all the concerned candidates that the Board shall conduct the First Round of Online Counselling for admission to GNM/ANM Courses-2025 w.e.f. 28-08-2025 (4:00 P.M. onwards) to 02-09-2025 (Midnight).

It is for the information of all the candidates that the seats shall be allotted based on the credentials of the candidates mentioned in **Annexure-A** to the Notification No. 057-BOPEE of 2025 Dated 10.06.2025. The Board shall in no case be held responsible if a seat is allotted to any candidate based on the incorrect category mentioned in the online application form.

## Note:

- 1. No representation shall be accepted /entertained by the Board through any Email or WhatsApp mode.
- The online filling up of choices/preferences shall be available w.e.f. 28-08-2025 (4:00 P.M. onwards) to 02-09-2025 (Midnight). The instructions related to filling out online Choices/Preferences have already been mentioned in the Counselling Procedure, which is available on the official website of the Board (www.jkbopee.gov.in) only.
- 3. Further, the candidates must pay an online counseling fee of Rs. 1000/- as mentioned in the e-Information Brochure/counselling procedure, and after submitting the online Preferences, the candidates must take out a print of it and ensure that the payment of Rs. 1000/- must be reflected in the payment column.
- 4. The Board shall provisionally allow all such candidates to participate in the online counseling process who have failed to upload any of the documents, viz. Domicile Certificate, 10<sup>th</sup> Class Marks Card, 12th Class Marks Card/Diploma for the purpose of ascertaining the D.O.B., etc., with the condition that they must fulfill all the eligibility conditions as mentioned in the Notification No. 033-BOPEE of 2025 dated 03.04.2025 and have to submit all such documents at the time of their admission in the respective college, if selected.

- 5. It is further ensured that all the candidates concerned ensure the validity of the Category Certificate, which in any case should not have been issued after **02-09-2025**, i.e., the last date fixed by the Board for filling out online preferences for the GNM/ANM Courses, 2025.
- 6. The seats shall be allotted to the candidates as per **S.O. 176 dated 15-03-2024**, read with **S.O. 305** dated **31-05-2024** issued by the Social Welfare Department, UT of J&K.
- 7. Seat Matrix shall be uploaded on the website of the Board a day before the start of Counselling.
- 8. Regarding the **fee structure** of the courses, participating candidates are advised to confirm it from the respective College/Institute where they intend to seek admission before applying for the online process.
- 9. Mere filling up of the online Preferences/ Choices shall not confer any preferential right/claim upon the candidate concerned for admission to any course/college, which shall further be subjected to eligibility to be verified at the time of admission, if selected, by the respective College/Institution.
- 10. The admission of the candidates is purely provisional. It shall be liable to be cancelled in case any information provided by any candidate is proved to be false/fabricated/untrue at any stage. The Board reserves the right to cancel the same and take penal action as per the relevant rules against the candidate concerned.
- 11. The candidature of any such candidate who is found ineligible at any stage of admission shall be cancelled without any further notice.
- 12. The other Terms and Conditions shall remain the same as notified by the Board through the e-Information Brochure, Notifications & Notices issued from time to time in this regard.
- 13. This notification remains available on the official website of the Board, viz., www.jkbopee.gov.in, only.
